IMPACTS OF SEASONAL WEATHER ON LANDSCAPING

April 25, 2024

Landscaping in the Peppertree community is expected to be impacted by changes in seasonal weather.

Spring rain showers and warmer temperatures are expected to cause seasonal blooms, the rapid growth of shrubs, and the increased and extensive appearance of weeds or other unwanted plant life.

Due to the budget reductions, which were effective July 1, 2023, residents may continue to notice the deferral, elimination, and/or decrease in the frequency of certain landscaping services and irrigation practices the Peppertree community received in previous years.

As part of the service reductions, the occurrence of shrub pruning has been reduced from three times per year, to one time per year.

The City will make every effort to address landscaping issues in a timely manner, however, recent budget constraints have reduced the City's available resources.
