 The safe parking use authorized by this approval shall be in substantial conformance with the written description and project plan sheets date-stamped approved on, unless modified herein. The safe parking use shall not be transferable to any firm, individual, or other address. Any substantial change or modification of the project application or conditions will necessitate the filing of a new safe parking permit application as determined by the Permit Administrator. The permit shall be valid for one year from the date of issuance. The safe parking permit shall expire one year from the date of issuance and a new permit must be obtained for use after the one-year period. If necessary, to ensure the public health, safety, and welfare, the Permit Administrator may impose additional operating conditions and restrictions upon the proposed project. The permit may be revoked by the Permit Administrator effective immediately upon verbal or written notice of violation of the terms of the permit. Verbal notice shall be confirmed by written notice mailed to the applicant/permit operator within two working days. If a building permit is required, the Building Safety Division shall review and approve all building permit plans prior to issuance of the building permit. I authorize the City and related Divisions to conduct random and scheduled inspections of operations to ensure life and safety requirements are adhered to(Applicant Initial)
