RESOLUTION NO. 2022-212

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FAIRFIELD AUTHORIZING A LOAN AND BUDGET TRANSFER FROM THE INTERGOVERNMENTAL LOAN FUND TO LANDSCAPING AND LIGHTING MAINTENANCE DISTRICT NO. 6 – PEPPERTREE FOR LANDSCAPE MAINTENANCE SERVICES THROUGH THE FISCAL YEAR 2022-2023 AND AUTHORIZING AN UPDATE TO THE FISCAL YEAR 2022-2023 BUDGET

WHEREAS, on April 19, 2022, City staff informed the City Council that fiscal year (FY) 2022-2023 assessment revenue for Landscaping and Lighting Maintenance District (LLMD) No. 6 – Peppertree is insufficient to provide a level of landscape maintenance services comparable to the level of services provided in FY 2021-2022; and

WHEREAS, the council may approve intergovernmental fund loans in accordance with the Interfund Loan Policy; and

WHEREAS, the council may set the interest rate at 0% in accordance with Resolution 1991-213B; and

WHEREAS, the projected shortfall was initially calculated at \$40,000; and

WHEREAS, the council authorized staff to offer a \$40,000 loan from the Intergovernmental Loan Fund to LLMD No. 6 — Peppertree, which would be repayable over five years in equal annual installments beginning in FY 2023-2024 with 0% interest to provide landscape maintenance services at the FY 2021-2022 levels through FY 2022-2023; and

WHEREAS, the shortfall was recalculated to be \$28,000; and

WHEREAS, a community survey was conducted from May 27, 2022, to July 22, 2022, to ascertain property owners' level of support for, or opposition to, receiving a loan and paying a greater assessment rate for five years to repay the loan; and

WHEREAS, providing for the loan to bear 0% interest will not pose a financial hardship to the General Fund; and

WHEREAS, funding was not allocated in the City's approved FY 2022-2023 Budget, thus requiring an adjustment in the amount of \$28,000 to cover the loan amount; and

WHEREAS, the revised appropriation constitutes an update to the FY 2022-2023 Budget approved pursuant to Resolution No. 2022-122.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF FAIRFIELD HEREBY RESOLVES:

Section 1. The council hereby approves a budget adjustment and transfer of \$28,000 from the General Fund (Fund 011) to the Intergovernmental Loan Fund (Fund 551).

Section 2. The council hereby approves a loan, budget adjustment, and transfer of \$28,000 from the Intergovernmental Loan Fund (Fund 551) to LLMD No. 6 – Peppertree (Fund 076).

Section 3. The loan shall be issued with a 0% interest rate and shall be repayable over five years in equal annual installments beginning in FY 2023-2024.

Section 4. The loan repayment will occur from assessment revenues available either as a result of increased assessments approved pursuant to a Proposition 218 proceeding or a reduction in services.

Section 5. The director of public works is hereby authorized to do all things necessary to implement this resolution.
