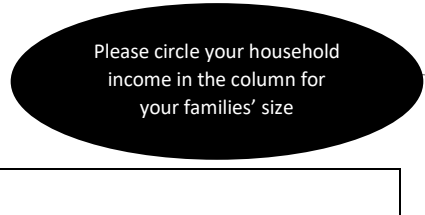

WAIVER

The City of Fairfield & Fairfield PAL have in place preventative measures to reduce the spread of COVID-19 during its activities; however, we cannot guarantee that you or your family will not become infected with COVID-19. Fairfield PAL Membership Agreements

Participants must be registered as a current PAL member and have a PAL Photo ID to attend any program or event held by Fairfield PAL. **Memberships are good for one year. The registration system will not recognize expired memberships, so we are unable to allow members to attend with an expired membership.**

Registration is accepted at only at the Fairfield Community Center. Membership is open to any Fairfield, Suisun, or Travis resident aged 13-18 who are enrolled in middle or high school. **(Valid Residency/school/age verification is required at the time of registration.)** Memberships are FREE!

Participants must sign in and out at the front desk each time they enter and leave the PAL Center. **An adult signature is not required for a member to leave or enter.**

- AT PAL, everyone is safe and responsible for making sure others are physically and emotionally safe, too.
- At PAL, we are considerate of others—we do not use dehumanizing language or impolite body language.
- At PAL, we follow directions the first time and do our best to listen to others.
- At PAL, we all try our best to follow the Alive & Free framework.

PAL membership is a privilege and not guaranteed.

We cannot be responsible for lost or stolen items. Members are encouraged to use the lockers when available, always keep items on their person, or leave valuables at home.

Participants who do not follow the rules or staff direction will need to **leave the facility immediately** and will not be able to return until they successfully complete a Restorative Justice Conference or 3 Brief Intervention Sessions. Gang, profane, any alcohol, tobacco or drug related attire may not be worn at any time.

Members are responsible for keeping the center clean. This includes picking up after yourself but also assisting staff in clean up when asked.

Everyone must sign in and out at the front desk to be in the building each day. Your entrance of the building signifies your understanding and willingness to follow all rules and agreements listed here or as directed by staff.

PAL utilizes a restorative justice model for significant or repeated behavioral issues. The goal is to grow skills and change behaviors that aren't beneficial. However, it also requires that parents / guardians participate along with members. Members may be unable to attend the center until a restorative justice conference / or BI Sessions can be held. Agreements from the RJ or BI may not be appealed. **Uncooperative members may be unable to participate in any PAL programming without a parent / legal guardian to supervise them.** As a youth serving organization, PAL is obligated to follow Senate Bill 506. This legislation will cover parents / guardians on site to assist with supervising their child as part of a restorative justice agreement.

PAL Memberships are good for one year. Members must re-register with updated documentation and a new registration form once a year at the Fairfield Community Center.

The following is not permitted:

- ✓ **Foul or destructive / dehumanizing language towards anyone**
- ✓ **Unkind body language**
- ✓ **Fighting (even "play")**
- ✓ **Bullying or teasing of any kind (including "play"). "I was just joking" does not make something okay.**
- ✓ **"Borrowing" (or stealing) of personal or PAL Center objects without permission of the owner in advance**
- ✓ **Gum and sunflower seeds or littering**
- ✓ **Gambling**
- ✓ **Food around / on the computers, video games, in the boxing area, or on the wood floors**
- ✓ **Sitting on anything other than a chair**
- ✓ **Public displays of affection (including hugging) / we follow social distancing guidelines at all times**
- ✓ **Bouncing balls against any walls/windows or hanging on basketball nets or rims**
- ✓ **Entering the boxing area except during structured boxing class times and when "dressed out."**
- ✓ **Being in unsupervised / closed areas**
- ✓ **Not following staff directions for any reason**
- ✓ **Recording / filming anyone using devices not approved by center staff and participants *in advance***
- ✓ **Using the basketball court unsupervised or when not opened per the program calendar**
- ✓ **For safety reasons, members may not wait outside in the parking lots for their ride**

Members may be asked to participate in evaluation activities such as questionnaires and focus groups with questions including what they learned in, their understanding of key concepts, views on healthy and unhealthy beliefs/behaviors and general satisfaction with the program. Participant demographic and attendance data is collected. All data collected will be anonymous and members may choose to participate or not. **Parents / Guardians are responsible for ensuring that their children are picked up from the PAL Center before closing or the end of the activity they are signed up for.
