

LLMD NO. 12 – DOWNTOWN BUSINESS DISTRICT NEWS

LANDSCAPE MAINTENANCE SERVICE REDUCTIONS September 7, 2023

Effective July 1, 2023, landscape maintenance services in Landscaping and Lighting Maintenance District (LLMD) No. 12 – Downtown Business District have been reduced based on the available fiscal year (FY) 2023-2024 budget.

Following a community engagement and Proposition 218 balloting process, a ballot tabulation was held on June 7, 2023, which confirmed that a majority protest was filed by property owners in the Downtown Business District community against increased assessments and the formation of a new maintenance district that would have replaced the existing LLMD.

Service reductions include the deferral, elimination, and/or decrease in the frequency of certain landscaping services and irrigation practices. Specific reductions are outlined on the attached chart.
